- (iii) To grant scholarship to deserving poor students for the purpose of prosecuting their education or research including tuition fees, clothing, books and hostel expenditure .



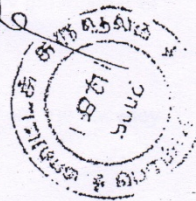

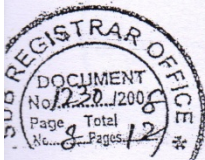

18. BENEFICIARIES OF TRUST:

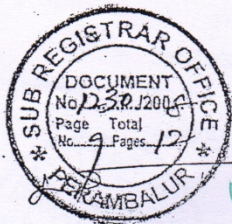
The benefits of the trust shall be opened to all irrespective of caste, race, creed and religion.

And it is hereby declared that the relief to be granted as here in above mentioned shall not be limited or restricted to persons of any particulars caste or creed or religion.

So far as it is not inconsistent with objects herein mentioned.

- (i) The income as also the corpus of the trust fund shall be applied and be applicable only to or for such public charitable purposes only and within such territories and subject to such conditions or limitations if any as may from time to time be laid down in the Income Tax Act 1961 or any other act governing tax on income as well insure or for exemption for taxation under the Income Tax Act 1961, or any reenactment thereof or modification thereof or under any other act governing taxation for the time being in force in India.

20, AMENDMENTS:

Any of the terms of this deed including the trust purposes set out here of may be varied, extended or amended from time to time by a instrument in writing under the hands of the trust to be approved by them at a meeting convened for that specific purpose. Provided no variation, extension of amendment shall be valid if it is contrary to or inconsistent with the trust purposes set out hereof, further no amendment shall be carried out without the prior approval of the Commissioner of Income tax.

"No amendments to the Trust Deed and rules and regulations shall be made which may prove to be repugnant to the basic character/objects of the Trust and to provisions of Section 2(15), 11 to 13 and 80-G of Income tax Act 1961*

SPENDING AND UTILISATION OF TRUST FUNDS AND DISSOLUTION THERE OF

The trustees shall be entitled to spend any amount or utilize the whole corpus of the Trust Fund Estate in furtherance of all or more of the objects of the Trust and for that purpose shall have full authority to purchase, sell, mortgage, exchange or otherwise dispose of any immovable or movable property outstanding etc., or transfer the same for the said purpose. The trust shall be dissolved by the trustees by passing a resolution to that effect when the whole of the corpus or the Trust Fund/Estate has been utilised to the last paise and the trustees are unable to collect further donations and contribution for carrying out the objects of the trust or the trust is amalgamated with any other trust and which enjoys recognition under 80G of the Income Tax Act 1961.

The trust hereby established shall be one to which provision of Sec.80G of Income Tax Act 1961 or any replacement or modification thereof for the time being inforce may apply so that any donation made there to recognized as eligible for exemption or relief from tax or in the hand of donar.
